

# POLICY FRAMEWORK: KEY POLICY INITIATIVES AFFECTING PEOPLE OF COLOR IN ARIZONA

#### INTRODUCTION

**Today,** I will provide an overview of several key policy issues that are having significant impacts on the lives of people of color in Arizona. These efforts range from promoting health equity and addressing homelessness to fostering economic empowerment through collaborative partnerships. These issues form the foundational framework of our advocacy and policy agenda as we spend the next few days here in Washington, DC, attending the Congressional Black Caucus and meeting with legislative and congressional representatives.



### 1. HEALTH EQUITY EFFORTS

Arizona is making strides in health equity by identifying and improving 21 organizational and 17 workforce capacities. The Arizona Department of Health Services is driving systemic changes in programs and professional development to embed racial equity as a core value.

Investing more funding targeting community health clinics and initiatives targeting the African American population, prioritizing culturally appropriate outreach strategies, improving data collection and analysis, creating more vibrant and trusted communication networks, and increasing funding to small businesses and advocacy groups will improve health policies and outcomes.

### 2. ADDRESSING HOMELESSNESS AND HOUSING AFFORDABILITY

The City of Phoenix's Housing Phoenix Plan aims to create or preserve 50,000 homes by 2030, targeting housing shortages and homelessness. With over \$21 million in federal HOME-ARP funds and the approval of a \$65 million bond led by Councilwoman Hodge Washington for affordable housing, the city is leading efforts in both affordable housing development and neighborhood revitalization.

We also applaud the City of Tempe under the leadership of Mayor Corey Woods, and other cities across Maricopa County for their effort to create more affordable and attainable housing. To that end, we advocate for increased funding for first-time homebuyer assistance with down payment assistance, rate buy down, and closing cost programs.

### 3. FINANCIAL SUPPORT FOR ENTREPRENEURS

Financial empowerment programs like the BIPOC Community Managed Loan Fund have provided over \$400,000 in no-interest loans to entrepreneurs of color. Partnerships with organizations like Wells Fargo and Growth Partners Arizona extend support through grants, mentorship, and financial literacy. In addition, we advocate for training programs targeting high demand areas in our economy including the energy and technology sectors.

The Black Philanthropy Initiative's SEE ME Program offers direct support to African American businesses, shaping a robust support system for black-owned enterprises to thrive. These collaborative partnerships will help build out an ecosystem that supports and helps African American businesses grow and thrive in Arizona.

#### 4. ENVIRONMENT AND SUSTAINABILITY

This year, Phoenix will break its record of consecutive days of temperatures over 100 degrees. Extreme heat should be included in the same category of other weather-related emergencies with appropriate FEMA and other federal government resources applied accordingly. We advocate for increased funding and policy actions to address the financial burdens, shelter, and health-related impacts of our rising temperatures.

Energy affordability remains challenging for all communities in a rising rate and cost environment. Therefore, increased funding to support programs like the Low-Income Home Energy Assistance Program and other federal and state initiatives are critical for those in need of financial assistance, especially during our Arizona summers when our energy bills double and sometimes triple.

Water resources must also be managed carefully with appropriate oversights to ensure our communities, cities, and towns are effectively managing their usage and conservation. This resource must be allocated equitably as the Greater Phoenix population continues to grow.

### 5. COMMUNITY ENGAGEMENT AND INFRASTRUCTURE DEVELOPMENT

Community engagement is essential to building lasting relationships with underserved populations. Organizations focused on and led by African Americans are well underfunded when compared to others and this must change. These organizations need real investments, dare I say "transformational" investments, not small local grants, to make consequential positive changes in the communities and populations they serve.

African American organizations trail in the amount of money invested to support their long-term sustainability. These are organizations people depend on to help educate, clothe, feed, develop, and build our communities. It is imperative that funding is directed to our community in the similar manner that funding is directed to other communities.

To that end, I applaud SRP and Rob Taylor specifically, for your efforts to address the needs of our community. Under his leadership, he has increased the attention on these and other issues including SRPs work in the Randolph community. While still a work in progress, this is an example of how transformational investments can change the direction and future of a community. I encourage SRPs continued investments and partnerships where your presence can have a material impact and change people's lives for the better.

#### IN CONCLUSION

While many additional issues impact our community, including improving education access and outcomes, addressing social justice issues, childcare, elder care, and business ownership, and combating inflation to lower the cost of living for us all, these are some of the foundational ones we will discuss here this week.

These discussions will open further opportunities to engage with lawmakers and stakeholders effectively and lay the groundwork for long-term positive change for people of color in Arizona.

Dorothy Jean's accomplishments didn't happen in isolation. She credits her incredible journey to

First, a former Chicago Alderwoman, and her mother, Jimalita Tillman, whose unwavering love and guidance nurtured her gifts. Jimalita's recognition of her daughter's abilities at a young age set Dorothy on a remarkable academic trajectory that defies stereotypes about single parenthood and homeschooling. Through their combined efforts, Dorothy Jean has not only achieved academically but has also made a lasting commitment to her community by promoting STEAM education. Dorothy Jeanius truly embodies the power of family, resilience, and vision. Thank you, Dorothy Jean and Jimalita, for your incredible inspiration.



This event reminds me of another experience more than two decades ago when I was invited to the San Carlos Indian Reservation in Northern Arizona for the beautiful Sunrise Dance ceremony by my dear friend, Mary Kim Titla, the only Native American and Apache newscaster in Arizona at that time. This four-day coming-of-age ritual marked the transition of young girls into womanhood, a celebration of heritage, strength, and community. It was at this ceremony that I first met Dr. Kenja Hassan, a young and promising staff member at ASU who would soon prove to be a trailblazer.

Kenja's warmth, intelligence, and engagement were apparent even then, but little did I know the extraordinary impact she would have on Arizona. A graduate of Princeton University and Arizona State University, with expertise in American Indian traditions, Kenja has since earned her Ph.D. and is now the Assistant Vice President of Government and Community Engagement at ASU. Her list of accolades is long, but her true greatness lies in her unwavering dedication to serving Arizona's Black community and beyond. Dr. Hassan's story is a testament to the heights that can be reached through hard work, compassion, and service.

As we reflect on this symposium, we are reminded of the extraordinary women who are redefining possibilities and leading the way for future generations. Dr. Dorothy Jean Tillman II and Dr. Kenja Hassan exemplify the highest levels of achievement and community dedication. To the students and stakeholders who attended this event, I urge you to take their stories as fuel to propel your journey forward. Aspire to embody their selflessness, perseverance, and commitment to creating positive change.

### SPOTLIGHT ATTENDEE, DR. KENJA HASSAN



As Assistant Vice President for Cultural Relations, Kenja Hassan serves as a liaison between ASU and diverse communities throughout the Valley. Throughout her time at ASU, Kenja Hassan has worked to forge relationships with diverse communities throughout the state of Arizona. Kenja has brought college preparation programs to American Indian youth on reservations, orchestrated national dialogs on pressing issues in the Nation's capital, guided student service projects across Arizona, and launched a series of reports on the status of Arizona's diverse communities.

Kenja serves on the City of Phoenix Fast Track Cities Committee, working to end the HIV epidemic. She is a member of the Advocacy Committee of the Metro Phoenix YWCA and the African American Women's Giving and Empowerment Circle at the Arizona Community Foundation. She has served on boards including Trellis, which addresses affordable housing, Arizona Saves, which provides financial education training, and Asian Pacific Community in Action, which offers healthcare support to Arizonans in need.

She is a Valley Leadership's Class 35 member and was recognized by the Phoenix Business Journal as a Forty under 40 leader and Diversity Champion. For her work to build bridges and strengthen Arizona communities, Kenja has been recognized by the City of Phoenix Human Relations Commission, the Arizona Martin Luther King Jr. Celebration Committee, Asian Corporate and Entrepreneur Leaders, the Black Board of Directors Project, the NAACP, the Phoenix Suns and PetSmart. She received a prestigious Rosa Parks award in from the Association for Access Equity and Diversity.

Kenja was a Rotary ambassador to Japan which resulted in ASU being the focus of a global study on how Japanese universities can be more strategically engaged in their local communities.

Ms. Hassan holds a B.A. in Religion from Princeton University and an M.A. in Religious Studies from Arizona State University, emphasizing American Indian traditions. Her writings on American Indian religious land claims have been presented before Congress and published in a compilation of oral histories.



Hugh Joseph "Rusty" Hassan, a prominent jazz journalist and radio presenter, has been a key figure in the Washington D.C. jazz scene for over 50 years. Born in 1945 in Bound Brook, NJ, and raised in Greenwich, CT, Hassan's love for jazz began early, attending the Newport Jazz Festival at age 17. After moving to D.C. for college at Georgetown University, he became deeply immersed in the local jazz scene, frequenting iconic venues like Bohemian Caverns and witnessing performances by legends such as John Coltrane and the Ramsey Lewis Trio. Over the years, Hassan has built a rich career interviewing renowned artists like

Dexter Gordon, Art Blakey, and Mary Lou Williams, and has played an influential role in broadcasting jazz through his long-running show on WPFW 89.3 FM.

In addition to his contributions to jazz journalism, Hassan was involved in the redevelopment of Washington, D.C., during the aftermath of the U Street riots and the city's urban renewal projects, helping to rehouse displaced residents through his work with a redevelopment aid agency. His passion for both jazz and community work has made him a respected figure, not only in music circles but also in D.C.'s broader cultural and social landscape.

**Sondra "Sandy" Barrett Hassan**, a native Washingtonian, began quilting in the 1970s, creating crib quilts for her daughters and gifts for loved ones. In 1984, she joined the Daughters of Dorcas, a DC chapter of the National Quilting Association, and later became a member of Uhuru Quilters. Her vibrant and bold fiber art has been featured in prominent galleries and museums, including the Smithsonian and the Corcoran Art Gallery. Sandy's quilts are also highlighted in two books—\*Communion of the Spirits\* by Roland Freeman and \*Spirits of the Cloth\* by Carolyn Mazloomi. She was commissioned to create quilt blocks commemorating historic sites for D.C.'s bicentennial and has been featured on the national television show \*B. Smith with Style\*.

Sandy's quilting process is deeply personal, focusing on color and emotion, drawing inspiration from bold African prints, batiks, and designer fabrics. She is driven by the joy of creating, often viewing each finished quilt as a stepping stone to her next project. Paste this into your browser to see Sandy's quilts. Beyond quilting, Sandy enjoys gardening, singing, and dancing. A former member of the African Heritage Dancers and Drummers, she also performed with the acapella group In Process. Sandy is married to jazz educator Rusty Hassan, with whom she has two daughters and two grandchildren, and she works full-time for the D.C. government.





# SPOTLIGHT ATTENDEE KATHRYN (CHE") COLLINS



**Kathryn (Che') Collins,** Program Director, Construction in Training (CTP) Education Center is an ASU Graduate with a bachelor's degree in communication studies, with an emphasis in Organizational Communication and Marketing. She also completed 18 hours toward her master's degree in educational leadership.

Before coming to Habitat, Che' had a 20-year career history with the Job Corps administration, a program administered by the United States Department of Labor that offers education and vocational training to underserved men and women ages 16 to 24.

During her tenure with Job Corps, she served as the Center Director for the Sacramento, Mississippi, and Roswell New Mexico Job Corps Centers.

During her tenure with the Phoenix Job Corps Center as the Project Director, she was responsible for the Career Transition service sub-contract, which under her leadership ranked number 3 in the nation out of 124 Job Corps contracts for a year and ranked in the top 10% for the remainder of the contract. She also served as the Deputy Director of Programs and the Area Director for the Phoenix Job Corps Center. The Department of Labor San Francisco Region recognized her outstanding performance in business and political development relationships as the Business and Community Liaison.

Che' was an active member of the board of directors for the Sacramento and Mississippi Workforce Develop Board of Directors, and Youth Council. Che' currently serves as a Board member and committee member for the Maricopa County Workforce Development Board Directors. She also sits on the Arouet Foundation Board of Directors, a Second Chance organization that serves women transitioning out of the prison system, and serves on the City of Surprise Mayor's Veteran Round Table committee.

### KATHRYN (CHE") COLLINS (CONT.)



Paul Collins, born in Muskegon, Michigan, and raised in Grand Rapids, is a celebrated artist whose journey began with a deep passion for art and a determination to overcome societal doubts about its practicality. Despite early discouragement, Collins found inspiration in Randy Brown, a Southern-born artist and poet, who encouraged him to pursue his dreams. This early mentorship and Collins' experiences growing up in a predominantly Black neighborhood profoundly influenced his artistic perspective and career. He later became known for designing prestigious awards such as the Martin Luther King, Jr. Non-Violent Peace Prize Medal, commissioned by Coretta Scott King, and the Challenger 7 Space Shuttle logo and many others.


Collins' work has been exhibited globally, from the Pushkin Museum in Moscow to the Kennedy Center in Washington, D.C., and can be seen in schools, libraries, and community centers across the U.S. He is passionate about teaching, often using his art to educate children on different cultures. Throughout his career, Collins has received numerous awards, including the People's Choice Award in Paris and the Golden Centaur of Italy. He has also served on prominent boards such as the Martin Luther King, Jr. Board in Atlanta and the Kennedy Center, solidifying his legacy as one of America's top twenty painters.

Dear Colleague,

With Hunger Awareness Month approaching, we invite you to cosponsor our bill to rename the National School Lunch Act (79 P.L 396, 60 Stat.230) from the Richard B. Russell National School Lunch Act to the Jean E. Fairfax National School Lunch Act.

The National School Lunch Act is the federal law that created the National School Lunch Program (NSLP) to provide free or low-cost school meals to eligible students through subsidies to schools. NLSP is one of the most successful food assistance programs in the country, where over 13 million children participate in school meals at no charge.

Richard B. Russell, Jr, who the law is currently named after, was an ardent supporter of white supremacy and segregation, and infamously filibustered civil rights legislation and co-authored the Southern Manifesto. These harmful beliefs inevitably seeped into the architecture of the National School Lunch Act, where he was the lead sponsor of the bill. It is even evidenced that he dismissed concerns of child-welfare advocates, civil rights activists, and women-led organizations <u>during debate</u> over the implementation of the National School Lunch Program. When there were obvious inequities of the NLSP after its roll-out, Jean E. Fairfax was committed to addressing them.

Jean E. Fairfax created and led The Committee on School Lunch Participation—a coalition of 5 national organizations whose combined constituencies totaled over 30 million women. The Committee studied the operations of NSLP in 40 school districts nationwide and conducted over 1,500 interviews among officials in the Department of Agriculture and state, school, and community stakeholders. The results from this study were compiled in the 1968 report, titled *Their Daily Bread*. Testifying before Congress on multiple occasions to present the findings of their report, Fairfax and other committee members were instrumental in making NSLP more inclusive. The report helped prompt Congress to establish the Special Food Service Program for Children, which became the Child Care Food Service Program and the Summer Food Service Program. The Committee's work also persuaded President Nixon to increase funding for the National School Lunch Program serving children in areas of concentrated poverty.

It is time we recognized the unsung heroes of food and nutrition assistance in this country. Join me in this effort to rename the National School Lunch Program Act (NSLA) after Jean E. Fairfax.

### CAREER AND CIVIL RIGHTS WORK



Jean Emily Fairfax had an extensive career in education and civil rights activism:

- Served as Dean of Women at Kentucky State College (1942-1944) and Tuskegee Institute (1944-1946).
- Worked with the American Friends Service Committee, including as a postwar relief worker in Austria and director of civil rights programs.
- Joined the NAACP Legal Defense and Educational Fund (LDF) in 1965, becoming the founding director of its legal information and community services division until 1984.
- Played a crucial role in shaping LDF's direction on issues like black college integration and employment discrimination cases.



After retiring from the LDF in 1985, Fairfax moved to Phoenix, Arizona, and focused on philanthropy with her sister Betty:

- Established endowments worth over \$1 million for social justice programs and scholarships.
- Created the Dan and Betty Inez Fairfax Memorial Fund to expand educational opportunities for African American and Latinx students.
- Founded the Black Legacy Endowed Fund.
- Established the Jean Fairfax Scholarship at the University of Michigan.



Jean Fairfax passed away on February 12, 2019, in Phoenix, Arizona, at the age of 98. She left behind a powerful legacy of civil rights advocacy, educational equity, and community service that continues to inspire and impact lives today.

Jean Fairfax had a profound and lasting impact on educational equity for African Americans through her tireless work as a civil rights activist, educator, and philanthropist. Her contributions were multifaceted and far-reaching:

### LEGAL ADVOCACY

As the founding director of the NAACP Legal Defense and Educational Fund's (LDF) legal information and community services division from 1965 to 1984, Fairfax played a crucial role in shaping the organization's direction on issues of educational equity. Her most significant achievement in this area was her involvement in the landmark case Adams v. Richardson (1972), which compelled 10 states to desegregate their public schools or risk losing federal funding.

### SCHOOL INTEGRATION EFFORTS

Fairfax was directly involved in grassroots efforts to integrate schools in the South. In 1964, she courageously worked to integrate Carthage Elementary School in Mississippi, facing threats and resistance but ultimately succeeding in enrolling the first black student, Debra Lewis.

### SUPPORT FOR DISPLACED STUDENTS

When Prince Edward County, Virginia closed its public schools in 1959 to resist integration, Fair-fax acted. She facilitated the relocation of black students to other states so they could continue their education.



### RESEARCH AND POLICY INFLUENCE

Fairfax's strategic research shed light on issues affecting black communities, leading to significant policy changes:

- 1. Her work resulted in increased federal funding for high-poverty schools.
- 2. She contributed to the expansion of the National School Lunch Program.
- 3. She assisted black workers in submitting over 1,800 discrimination complaints to the Equal Employment Opportunity Commission.

### PHILANTHROPY AND SCHOLARSHIPS



After retiring from the LDF, Fairfax, along with her sister Betty, focused on philanthropy to continue their impact on educational equity:

- They established endowments worth over \$1 million for social justice programs and scholarships.
- In 1987, they "adopted" an entire eighthgrade class in Phoenix, providing \$1,000 scholarships to those who graduated high school and enrolled in a four-year college.
- They created the Dan and Betty Inez Fairfax Memorial Fund to expand educational opportunities for African American and Latinx students.
- Fairfax established the Jean Fairfax Scholarship at the University of Michigan.

Through these varied efforts, Jean Fairfax made significant strides in advancing educational equity for African Americans, from fighting legal battles for desegregation to providing direct financial support for students. Her work has had a lasting impact on the American education system and continues to benefit students today.

Jean Fairfax's work at the NAACP Legal Defense and Educational Fund (LDF) was a pivotal and defining period in her career as a civil rights activist and advocate for educational equity. Her tenure at LDF from 1965 to 1984 shaped her career in several significant ways:

#### LEADERSHIP ROLE

Fairfax served as the founding director of LDF's legal information and community services division. This leadership position allowed her to have a substantial impact on the organization's direction and priorities.

### STRATEGIC INFLUENCE

Jack Greenberg, LDF's longtime director-counsel, described Fairfax as the most influential staff member in shaping the direction of LDF on critical issues such as black college integration and employment discrimination cases. This highlights her strategic importance within the organization



### LANDMARK LEGAL CASES

Fairfax played a crucial role in significant legal efforts, including the landmark case Adams v. Richardson (1972), which compelled 10 states to desegregate their public schools or risk losing federal funding. Her involvement in such high-profile cases enhanced her reputation and expertise in civil rights law.

### **GRASSROOTS ORGANIZING**

At LDF, Fairfax continued her hands-on approach to civil rights work. She personally drove LDF attorneys through rural Mississippi to meet with parents about school desegregation decisions. This direct engagement with communities strengthened her understanding of the challenges faced by African Americans in the South.

### RESEARCH AND POLICY IMPACT

Fairfax's research reports at LDF meticulously detailed the struggles of impoverished black families and the failure of states to integrate their higher education systems. Her work led to increased federal funding for high-poverty schools and education programs, as well as the expansion of the National School Lunch Program.

#### ADVOCACY FOR HIGHER EDUCATION



At LDF, Fairfax fought for historically black colleges to prevent their downgrading or closure in the face of funding and program cutbacks. This work solidified her commitment to educational equity at all levels.

### REPUTATION BUILDING

**Sherrilyn Ifill,** LDF's former president, and director -counsel, described Fairfax as a "master strategist" and "an absolute legend at LDF". Her work at LDF significantly enhanced her reputation in the civil rights community.

Jean Fairfax's time at the NAACP Legal Defense and Educational Fund was transformative, allowing her to make lasting contributions to civil rights and educational equity while establishing herself as a respected leader in these fields. Her experiences at LDF informed and shaped her subsequent philanthropic work, creating a legacy that continues to impact lives today.



The Adams v. Richardson case was a landmark legal victory that played a significant role in Jean Fairfax's career at the NAACP Legal Defense and Educational Fund (LDF). Here are the key points about its importance:

- 1. Fairfax was instrumental in bringing this case forward during her tenure as founding director of LDF's legal information and community services division from 1965 to 1984.
- 2. The case, decided in 1972, compelled 10 states to desegregate their public schools or risk losing federal funding. This was a major achievement in advancing educational equity for African Americans.
- 3. As part of the ruling, the court ordered the Department of Health, Education, and Welfare (HEW) to begin enforcement proceedings against school districts and higher education systems that were still segregated despite receiving federal funds.
- 4. The case addressed the dismantling of dual systems of public higher education that persisted after the passage of the Civil Rights Act of 1964. This aligned with Fairfax's focus on higher education equity throughout her career.
- 5. It demonstrated Fairfax's strategic approach to civil rights advocacy, using legal action to force government agencies to fulfill their mandates in enforcing desegregation.
- 6. The success of Adams v. Richardson enhanced Fairfax's reputation as a "master strategist" within the LDF and the broader civil rights community.
- 7. This case was part of Fairfax's broader efforts at LDF, which included shaping the organization's direction on issues such as black college integration and employment discrimination cases.

In essence, Adams v. Richardson was a crowning achievement in Fairfax's career, exemplifying her effective approach to using legal means to advance civil rights and educational equity. It solidified her status as a key figure in the civil rights movement and demonstrated the impact of her work at the LDF.

As Fairfax said in an interview with the Christian Science Monitor: someone had to break the pattern, and very often the civil rights revolution was initiated by the most vulnerable Black persons. Many of them were women and many of them were children — tough, resilient, hopeful, beautiful children. The greatest experience of my life was standing with them as they took the risks."

# THE LEADERSHIP CONSORTIUM STUDENT LEADERSHIP INSTITUTE (TLC-SLI)

**The Leadership Consortium (TLC),** a 501(c)(3) non-profit organization founded in 1999 and incorporated in 2002, has a vision to promote leadership development within African American, Hispanic, and other communities of color. With a history of impactful programs and initiatives, TLC seeks to enhance the skills and capacities of individuals through professional training, career development, and instruction aimed at fostering leadership and community involvement.

Michael Kelly, one of the driving forces behind TLC, was pivotal in establishing the Community Alliance for Black Student Support, which later evolved into the Sankofa Leadership Institute in collaboration with Arizona State University. This program focused on recruitment and retention of African American students, underscoring Kelly's long-standing commitment to Black empowerment in Arizona. He also contributed to key community initiatives like the Arizona Black Film Showcase, the Arizona Black Expo, and the Linking Sports and the Community project. Additionally, Kelly co-founded the Black Philanthropy Initiative at the Arizona Community Foundation, promoting greater charitable engagement within the African American community.

In 2018, TLC, led by Kelly, launched the Black Brown and College Bound Program, in collaboration with Phoenix College Depot and the AKA Sorority, which significantly increased scholarship opportunities for African American and Hispanic students.

TLC's flagship initiative, the Arizona Delegation to the Congressional Black Caucus (CBC), first organized in 2014 with support from then-Councilwoman (now Mayor) Kate Gallego, has grown into a vital program for leadership development. Today, the 2024 Arizona Delegation boasted 137 participants, including leaders from various sectors—legislators, corporate executives, medical professionals, educators, and students from local colleges and universities. This event showcases the collective strength and future leadership potential of Arizona's African American community.

As Councilmembers, Kevin Robinson and Kesha Hodge Washington mentioned, In 2024, TLC expanded its outreach by launching the Leadership Consortium Student Leadership Institute, (TLC-SLI) aimed at empowering students from diverse institutions, including Arizona State University, South Mountain Community College, the University of Arizona, and Tulsa Community College. TLC-SLI provided comprehensive support for 18 students, one alumni and their chaperones to attend the CBC in Washington, D.C. Over the past three years, 24 students attended the CBC sponsored by TLC. We are making progress.

This year students engaged in a wide array of activities, including meeting with Arizona Senator Mark Kelly, attending the Kickoff Breakfast sponsored by SRP, Collegiate networking lunch sponsored by APS to honor Jean Fairfax, ASU CBC Reception at the O'Connor, Barrett Center in Washington, DC, a tour of Howard University, and other culturally enriching experiences such as visits to, the Capitol, and the National Museum of African American History and Culture.

As TLC continues to evolve, its efforts to revamp its website and implement succession planning reflect a forward-thinking approach to sustainability and future leadership development. The organization's ongoing mission remains focused on cultivating the next generation of leaders, ensuring that hundreds of individuals—regardless of background—can engage meaningfully with the CBC and other platforms for political, social, and economic advancement.

TLC's role in shaping leaders, fostering opportunities for students, and its ongoing collaboration with key partners demonstrates its vital contribution to the African American community and beyond. As the organization continues to grow, its impact will undoubtedly resonate across generations, ensuring the continued development of future leaders in Arizona and nationwide.

The TLC-SLI will become the foundation for our CBC experience. Because it provides numerous opportunities for students to engage in leadership development, policy analysis, and advocacy through their internship and scholarship programs. These initiatives fit well with our mission to empower the next generation of leaders, particularly those committed to serving their communities.

### Scholarship Programs:

CBCF offers over 300 scholarships annually, with awards ranging from \$3,000 to \$70,000. Scholarships are awarded to students who demonstrate leadership through community service and academic achievement.

### Internship and Leadership Programs:

While specific program names vary, CBCF internships prepare college students and young professionals for leadership roles in policy analysis, public service, and advocacy. These internships offer hands-on experience in shaping policies that impact African American and global Black communities.

### Annual Legislative Conference (ALC) Opportunities:

Students attending the ALC can benefit from:

Engaging with Policy Issues: Participate in workshops and panels on critical topics like healthcare, education, and social justice, while connecting with lawmakers and experts. These experiences also demonstrate to the students firsthand how their emerging expertise can play a role in shaping the future of the US.

<u>Professional Development:</u> Gain insights and skills to effectively advocate for change in their communities. Students also take advantage of broadening their professional networks in the unique environment of the ALC. The ALC is the largest convening of Black and African American elected officials, policymakers, and activists. In this environment, students are encouraged to build relationships with peers and mentors beyond their academic environments. The intentional inclusion of scholars from various stages of their professional journeys 2- and 4-year undergraduate programs,

various stages of their professional journeys 2- and 4-year undergraduate programs, graduate programs, post-baccalaureates, postdocs, and faculty) enables peer, near-peer, and seasoned peer mentoring to occur both during and beyond the ALC.

<u>Cultural Celebration and Engagement:</u> Student participants experience and celebrate the richness of Black culture through events, performances, and storytelling Visits to HBCUs and to the National Museum of African American History and Culture represent just two of the numerous activities that are available to them during this experience.

<u>Visibility and Involvement:</u> Opportunities to volunteer or engage with both local and national organizations, sponsors, and/or exhibitors for future conferences.

These programs and events provide a platform for students to not only further their education but also to gain experiential training and to directly influence and contribute to the advancement of policies impacting Black communities globally.



She is the co-founder and president of The Coalition of Blacks Against Cancer. She is an active member of the Phoenix community and is considered a leader in health disparities in the Black community.






### **BUILDING BLACK WEALTH**





**Dr. Reginald and Cymone Bolding** are a power couple whose impact spans across politics, education, finance, and civic leadership.

Dr. Reginald Bolding, a seasoned leader in Arizona politics, served nearly a decade in public office, most notably as House Minority Leader in the 55th Legislature. During his tenure, he led the largest Democratic Caucus since 1966, brokered historic investments in Arizona's water infrastructure, secured millions in nonprofit funding, and helped pass the first bipartisan state budget in over a decade. As the founder of two influential Black-led civic engagement organizations in the Southwest, Dr. Bolding has been instrumental in securing over \$300 million for school districts, electing two U.S. Senators, and leading Arizona's largest Black voter outreach program. His expertise extends beyond politics, as he is also an educator, investor, and national consultant addressing critical social and economic issues.

Cymone Bolding, the Chief Operating Officer at the National Association of Black Accredited Investors (NABAI), is dedicated to fostering inclusivity within the financial sector. By rethinking traditional equity structures, she creates opportunities for communities to thrive through purposeful, sustainable investments. Additionally, Cymone serves as a Teaching Fellow at Harvard, where she supports students in developing their leadership and storytelling skills in the "Public Narrative: Leadership, Storytelling, and Action" course, empowering them to lead with purpose.

Together, the Boldings are dedicated to driving equity and innovation in their respective fields. They reside in Phoenix, Arizona, with their three daughters, Faith, Grace, and Honor.

# Historically, The Leadership Consortium (TLC) has launched the following key programs.

- <u>Community Alliance for Black Student Support (CABSS)</u>: Established in 1999, this program, in partnership with Arizona State University, evolved into the San-ko-fa Leadership Institute, enhancing African American student recruitment and retention.
- <u>Arizona Black Film Showcase</u>: Founded in 2001 by Joanna DeShay, this event celebrated Black filmmakers and educated youth on filmmaking until 2011.
- <u>Linking Sports and the Community</u>: Launched in 2004 by Denise Meridith, this annual event highlighted career opportunities in sports-related fields for teens.
- <u>Arizona Black Expo</u>: Peaking in 2006, it provided networking opportunities for African American businesses, attracting over 10,000 attendees.

<u>Black Brown and College Bound Program</u>: Initiated in 2018, this program aims to increase scholarship opportunities for African American and Hispanic students through a partnership with College Depot and the Greater Phoenix Area Delta Beta Omega Chapter.

### History of the Community Alliance for Black Student Support

In 1999, with a focus on fostering a diverse workforce essential for economic growth, the Future Leaders Program was established for graduate students by Denise Meredith, the retired State Director of the Bureau of Land Management, in collaboration with Dr. Bianca Bernstein of the Arizona State University (ASU) Graduate College. This initiative aimed to attract, retain, and develop leaders among graduate students. In 2000, in response to concerns about the graduation rates of Black students, the late Dr. Elva Coor, wife of former ASU President Lattie Coor, initiated the African American Support and Retention Committee with a coalition of community leaders, ASU students, staff, and faculty.

In August 2001, these two programs merged to form the Community Alliance for Black Student Support (CABSS), formally organized to counter the social isolation that often affected African American students at ASU. CABSS provided critical early intervention and leadership development, laying a foundation for student success at the university and, more importantly, in the workplace. Bank of America supported this mission with grants totaling \$130,000 across 2001 and 2002, funding an Executive Director for CABSS.

CABSS established several objectives, including 1) growing the population of Black students, faculty, and staff to foster a visible community on campus; 2) increasing scholarships and fellowships; 3) building a strong mentoring network; 4) expanding internship opportunities; 5) providing leadership training; 6) enhancing job opportunities; 7) increasing social engagement for Black students; 8) making personal and financial resources more accessible; 9) identifying and supporting at-risk students; and 10) developing tracking mechanisms to measure progress.

### Among its notable accomplishments:

♦ Sankofa Summer Leadership Institute: A four-day annual residential program was created to help incoming freshmen and transfer students connect, access university support services, and engage with African culture, positively influencing retention rates.

- ♦ Collaborations with the Multicultural Student Center: This partnership introduced new programs for Black students.
- ♦ Community Engagement: CABSS worked closely with ASU faculty, staff, students, businesses, and community leaders to address student needs and enrich their ASU experience.
- <u>Pilot Program with Maricopa Community Colleges:</u> In alliance with South Mountain Community College, CABSS developed a model for future expansion.
- ♦ Internship Program with Fry's Marketplace: In 2003, CABSS offered five management internships.

Through the Sankofa Leadership Institute, students participated in workshops highlighting prominent figures of African descent throughout history and explored the role of African American college students. Students were introduced to key ASU organizations, including the Black and African Coalition, S.T.A.R.S. Association, Pan Hellenic Organizations, and events like the African American Welcome Back BBQ, African American Convocation, ASU Homecoming Festival, and the Black History Month Vendor Fair.

The ASU Multicultural Student Services office coordinated CABSS's outreach efforts. In 2006, postcards were mailed to all 850 African American students admitted to ASU, and a team of volunteers called 251 admitted and registered African/African American students. The program was also promoted through the Community newsletter and website, ultimately resulting in 75 applications, with 40 students accepted and 36 attending the Institute.

With support from SRP (Salt River Project) and various fundraising efforts, CABSS awarded between four and six \$1,000 scholarships to ASU graduate and undergraduate students and two \$250 book scholarships to high school students in the South Mountain Community College ACE (Achieving a College Education) program, which allowed them to earn college credits. Scholarship selection considered academic standing, community engagement, financial need, and personal or family hardships. CABSS contributed to increased African American student enrollment at ASU, building a legacy of support and community for Black students.

### **Testimonial from Brandy Ervin**

In the summer of 2003, I participated in the CABBS (Community Alliance for Black Student Support) Summer Bridge Program at Arizona State University. This transformative program was designed to support African American students transitioning from high school to university life, providing a unique opportunity to acclimate to the academic, social, and cultural environment of ASU before the start of the fall semester. The CABBS program was instrumental in preparing me for university life. Through workshops and seminars, I gained valuable insights into time management, study strategies, and how to access resources on campus, such as academic advising and tutoring centers. These foundational skills proved essential when I officially started my journey at ASU, allowing me to navigate the university's challenges with resilience and confidence.

The CABBS program was a space for building community and forming lifelong connections. The program brought together a cohort of like-minded, ambitious African American students who supported and encouraged each other throughout the summer and beyond. I forged deep bonds with many of the attendees, forming a support network that provided encouragement, mentorship, and friendship throughout my time at ASU. Many of these relationships have endured over the years, blossoming into professional networks and lifelong friendships.

The shared experience of navigating the program and then transitioning to university life created a sense of camaraderie and connection that remains strong to this day. CABBS also provided cultural enrichment, helping my peers and I explore our identities and histories within the context of higher education. This emphasis on cultural awareness and pride not only fortified my resolve to succeed academically but also ignited my passion for social justice—a passion that has guided my career ever since.

It was at the 2024 CBC ALC (Congressional Black Caucus Annual Legislative Conference) that I learned that Mr. Michael Kelly had been the driving force behind the creation of the CABBS program. Mr. Kelly's dedication to empowering young African American students continues to leave a lasting impact, with his efforts still resonating throughout the community today. The discovery that Michael Kelly, the very person who spearheaded the CABBS program, remains an active force in the community underscores the legacy of his vision. His ongoing efforts to empower and uplift young people are a testament to the impact that early guidance and community can have on individual lives. For me, CABBS was more than a summer program; it was the beginning of a lifelong commitment to making a difference.




**Barbara McConnell Barrett** is an American businesswoman, attorney and diplomat who served as the United States secretary of the Air Force from 2019 to 2021. She is also an instrument-rated pilot, and cattle and bison rancher.

As the 25th secretary of the Air Force, Barrett leads the affairs of the Department of the Air Force, comprising the U.S. Air Force and U.S. Space Force.

Barrett is a former chair of the Aerospace Corporation and a member on the boards of California Institute of Technology,[3] Jet Propulsion Laboratory, RAND Corporation, Smithsonian Institution, Horatio Alger Association of Distinguished Americans, and Lasker Foundation.

Barrett was appointed to the Board of Regents of the Smithsonian Institution by a joint resolution of the House of Resolutions and the Senate, filling the vacancy created by the expiration of David M. Rubenstein's tenure on the board.[8] Barrett's appointment will last for a term of 1912 days, ending on September 17, 2026.





#### SENATOR MARK KELLY

**Senator Mark Kelly** is an independent leader who came to the Senate to serve Arizona's working families, not corporate special interests.

As the son of two police officers, Senator Kelly learned the value of public service at an early age. He attended public schools from elementary school all the way through graduate school. Senator Kelly earned his B.S. degree in marine engineering and nautical science from the U.S. Merchant Marine Academy and later an M.S. degree in aeronautical engineering from the U.S. Naval Postgraduate School.

As a Navy pilot, he made multiple deployments on the aircraft carrier USS Midway and flew 39 combat missions in Operation Desert Storm. Senator Kelly is the recipient of the Defense Superior Service Medal, Legion of Merit, two Distinguished Flying Crosses, and multiple Air Medals.

He has logged more than 5,000 flight hours in more than 50 different aircraft and has over 375 carrier landings. Senator Kelly retired from the Navy with the rank of Captain. In 1996, he was selected as an astronaut in the same NASA class as his identical twin brother Scott. Senator Kelly's first of four trips into space was as pilot of STS-108 in December 2001, during which he helped deliver equipment, supplies, and additional crew members to the International Space Station.

All in all, Senator Kelly has spent more than 50 days in space — traveling over 20 million miles. He retired from NASA in 2011 after commanding Space Shuttle Endeavour on its final flight.

Now, Senator Kelly has embarked on his next mission — serving as a U.S. Senator for Arizona, in the seat once held by Senator John McCain. After being sworn in on December 2, 2020,



#### CONGRESSMAN AND ARIZONA SENATOR ELECT RUBEN GALLEGO



**Congressman Ruben Gallego** represents the 7th District of Arizona, including parts of Phoenix, Glendale, and Tolleson, in the U.S. House of Representatives. This Marine Corps combat veteran, and lifelong community leader, is the son of Hispanic immigrants. He was first elected in 2014. Representative Gallego was the first in his family to attend college, graduating from Harvard University.

Congressman Gallego served in the Arizona House of Representatives from 2010 until 2014. As a state legislator, Congressman Gallego became known for his tough stance against extreme legislation in the state legislature. He also led the push for Medicaid expansion and securing in-state tuition for veterans.

Representative Gallego has largely focused on U.S. national security, is a member of the House Armed Services Committee and CHAIR of the Intelligence and Special Operations subcommittee. As a member of the House Committee on Veterans' Affairs and Subcommittee on Economic Opportunity, Representative Gallego works to improve the health and wellbeing of veterans. This includes but is not limited to improving mental health care, funding to address veterans' homelessness in Phoenix and across the country.

As a member of the House Natural Resources Committee, he has fought to uphold Tribal sovereignty and our federal trust responsibility to Native Americans and Alaska Natives. He held the first-ever House hearing on Missing and Murdered Indigenous Women, led the fight to protect sacred spaces and affirm Tribal Nations' right to sovereign homelands, and championed investment in broadband and other critical infrastructure on Tribal land.

Congressman Gallego is a member and former First Vice Chair of the Congressional Hispanic Caucus, a member of the Congressional Progressive Caucus, a Vice Chair of the LGBT Equality Caucus, and a Democratic Caucus Assistant Whip.







Throughout his career, **Greg Stanton** has worked tirelessly to deliver results for Arizona families. Serving as Phoenix mayor from 2012 to 2018, he focused on building an economy rooted in innovation and trade. Under his leadership, Phoenix created thousands of quality jobs and recently saw the highest wage growth in the nation.

Greg has earned a reputation for working across the aisle to get things done. His biggest accomplishments in Phoenix were passed with bipartisan support: the City's investment in biosciences and higher education, support for small businesses, and national recognition for leadership on LGBT equality. **Bonnie Watson Coleman,** a distinguished public servant, currently in her fifth term in the United States House of Representatives, has dedicated her career to championing the rights of New Jersey families and advocating for equity among all individuals. She holds the distinction of being the first Black woman to represent New Jersey in Congress.

As a member of the Appropriations Committee, Watson Coleman plays a pivotal role in shaping federal spending priorities. She also serves as Chair of the Policing, Constitution, and Equality task force within the Congressional Progressive Caucus, where she actively contributes to progressive policy initiatives.

Born into a family with a rich history of public service, Watson Coleman carries on her father's legacy, the legendary state legislator John S. Watson. Her advocacy focuses on marginalized communities, women, and economically disadvantaged populations.

Before her tenure in Congress, she served eight consecutive terms in the New Jersey General Assembly. During this time, she shattered racial and gender barriers, becoming the first Black woman to hold the positions of Majority Leader and Chair of the New Jersey Democratic State Committee. Notably, she led efforts to reform prisoner re-entry programs, earning national recognition for her work in prisoner rehabilitation and release.

In 2016, Watson Coleman co-founded the Congressional Caucus on Black Women and Girls, highlighting the unique challenges and successes of Black women in policy debates. She also actively participates in several congressional caucuses, including the Congressional Black Caucus, the Congressional Caucus for Women's Issues, the Congressional LGBT Equality Caucus, and the Congressional Asian-Pacific American Caucus.

A well-educated leader, Watson Coleman is a graduate of Thomas Edison State College and has received honorary doctorate degrees from multiple institutions. She is a member of Alpha Kappa Alpha Sorority, Inc., and co-chairs the Girl Scouts of America Capitol Hill Honorary Troop. She resides with her husband, William, in Ewing Township, and they have three sons and three grandchildren.

Bonnie Watson Coleman continues to make a significant impact in Congress and remains committed to advancing the interests of her constituents and marginalized communities across the nation.







**U..S. Congressman Al Green**, a devoted civil rights advocate, embarked on his ninth term in the United States House of Representatives, representing Texas' 9th Congressional District, commencing on January 3, 2021. With a resolute dedication to amplifying the voices of the underrepresented, he's a staunch advocate for those often marginalized in society.

In the House of Representatives, Congressman Al Green serves on two significant committees. He's a member of the Financial Services Committee, actively participating in three subcommittees: Diversity and Inclusion; Housing, Community Development, and Insurance; and Oversight and Investigations, where he chairs. In 1977, he assumed the role of Justice of the Peace in Harris County, Texas, a position he held for an impressive 26 years until his retirement in 2004. Throughout his career, Congressman Al Green has earned the admiration of colleagues and community leaders for his legal expertise, impeccable character, and ability to collaborate with diverse individuals.

For a decade, he served as president of the Houston Branch of the NAACP, significantly expanding its membership and influence under his leadership. His outstanding service has garnered numerous awards and accolades, showcasing his unwavering commitment to the community.

In Congress, Congressman Al Green is a member of the Congressional Asian-Pacific American Caucus (CAPAC) and the Congressional Black Caucus (CBC). **MAYOR COREY WOODS** was elected mayor of the City of Tempe in March 2020. In his professional career, he is the Executive Director of Community Relations at ASU Preparatory Academy. He previously served as the chief operating officer for the Greater Phoenix Urban League, director of college and career articulation for the Phoenix Union High School District, and director of government relations for the American Lung Association of Arizona.

**Councilman Kevin Robinson** is a retired (36 1/2 yrs.) senior law enforcement executive with more than eighteen (18) years of upper management and executive level experience serving the fifth (5th) largest city in the United States. He is also a full time Lecturer in the Watts College of Public Programs and Community Solutions at Arizona State University where he instructs in the School of Criminology and Criminal Justice.

Councilman Robinson was elected to the Phoenix City Council representing District 6 – which includes the Ahwatukee, Arcadia, Biltmore, and North Central neighborhoods. He was sworn in on Monday, April 17, 2023.




A native of Phoenix, Arizona, Bishop Russell acknowledged at an early age the gifts and talents God had given him and his desire was to use them for Kingdom expansion.


#### DR. ASHLEY HODGE

#### RESTRUCTURING OF TLC - PRESIDENT & CEO COMMENTS

Good Afternoon, Colleagues,

For over two decades, I have had the privilege of attending the Congressional Black Caucus Annual Legislative Conference (CBC), a gathering that is both inspiring and challenging for African Americans across the nation. During these years, I have heard the jests and barbs from our brothers and sisters who, with a mix of humor and incredulity, have questioned Arizona's presence and our experience as African Americans in Arizona. Comments like, "Hey y'all, since 10 of you are here at the CBC, are there any Black folks left in Arizona?" or "Isn't that where Barry Goldwater was from?" were delivered with a wink and a nod. Others have offered sarcasm but not without an underlying curiosity: "What's it like being Black in Arizona? Didn't you all rescind the MLK Holiday?"

Though these remarks carried a sting, they also fueled a fire within me—a determination to shatter the myths and misconceptions about African Americans in Arizona. As the saying goes, "The best revenge is success," and we have indeed succeeded beyond measure.

I am incredibly proud to share that our journey from those humble beginnings, where only a handful of us represented Arizona at the CBC, has led to an extraordinary transformation. Today, I am pleased to announce that our Arizona Delegation to the CBC boasts over 120 registered participants—a formidable group representing the very best and brightest Black people in our state.

Our delegation includes State Legislators, esteemed members from the Governor's office, Mayors and City Council members from Phoenix, Tempe, and Avondale, as well as Judges, Magistrates, Attorneys, Medical Doctors, Ph.D.'s, Academic faculty, staff, Corporate Executives, Consultants, Municipal Administrators, Clergy, Community Leaders, and Non-Profit representatives. Perhaps most significantly, we are joined by the bright minds of tomorrow—students from Arizona State University, the University of Arizona, South Mountain Community College, and Tulsa Community College

The slings and arrows have now been replaced with admiration and respect. "Wow, I didn't realize Arizona had such prominent African American leaders," is a refrain we hear often, a testament to our collective efforts and the undeniable impact we have made.

None of this would be possible without your unwavering commitment, your tireless advocacy, and your belief in the potential of our community. Together, we have not just answered the questions posed to us—we have redefined what it means to be Black in Arizona.




